6. Department Reports

A. Administration: Tom Skjelstad, General Manager

1. Update of the DSPUD State Revolving Fund Construction Loan Application- status of the District's construction loan request for the DSPUD WWTP Upgrade and Expansion Project. Tom Skjelstad reported that staff continues to work with SRF staff in answering their questions and submitting more supporting documents. Most of the requests from SRF revolve around refinancing some of the District's existing debt.

The District has two loans with Bank of the West with a combined total amount of \$2,411,800 at 5.62% interest. Staff has requested and SRF wants to refinance the two loans with an interest rate of 2.2%. If the loans can be refinanced the District could save approximately \$140,000 per year in debt service.

Tom Skjelstad stated that he is optimistic that the Donner Summit Public Utility District will be on the State Water Resources Board agenda for the June 19 meeting.

- 2. Stantec Change Order No. 3- a Scope of Services for Final Project Environmental Permitting and Construction Surveys, Monitoring, Agency Coordination and, Reporting. Tom Skjelstad reported that change order #3 addresses the numerous set of permit conditions that must be implemented and coordinated prior to construction of the District Project. The regulatory agencies involved are:
 - CA Department of Forestry
 - US Army Corps of Engineers
 - Regional Water Quality Control Board, Central Valley Region
 - US Forest Service
 - USDA

- 3. Update on the DSPUD Wastewater Facilities Upgrade and Expansion Project- information relating to the rebid process for the Project. Tom Skjelstad reported that as directed by the Board at the May 2, 2012 Special Meeting, Stantec has advertised that DSPUD Board rejected all bids that were received on April 25, 2012 and the new bid opening date for the Project is Wednesday June 6, 2012 at 2:00 P.M. Four of the pre-qualified contractors have made it known that they will be submitting bids.
- 4. Update on the Cal Trans Rest Areas Billing- information relating to Cal Trans cost allocation of the DSPUD Wastewater Facilities Upgrade and Expansion Project. Geoff Evers again provided the Board of Directors an overview of the history between Cal Trans and the Donner Summit Public Utility District. A discussion ensued. Tom Skjelstad reported that Cal Trans has agreed to pay for 91 EDUs, (an increase of 66) at the regular rate less the upgrade and expansion portion of the rate. Geoff Evers is writing Cal Trans another letter addressing the matter of Cal Trans paying its portion of the upgrades and expansion.

The District has agreed to accept Cal Trans payments, less the improvement portion, until an agreement is reached. District staff will keep track of the improvement portion and will back charge Cal Trans once it has been decided that Cal Trans is not exempt from paying its share of the improvements.

5. DSPUD Water Treatment Plant Planning Loan- discussion of the District request to fund a planning loan for the Water Treatment Plant Improvements. Tom Skjelstad reported that The State of California Department of Public Health (CDPH) changed certain regulations for drinking water last year. These regulations affect the District water treatment facility in that the facility will need some improvements.

The District filed a planning loan application with CDPH requesting a loan to fund the necessary improvements. The CDPH responded that it is recommending funding for the planning loan and the District system has been categorized as a disadvantaged system and is eligible to receive up to 80% grant funding. Based on CDPH's calculations they plan to recommend a \$138,322 grant / \$34,581 loan amount. However, CDPH has a 1.2x total debt service coverage requirement. Based on the District's 2010-2011 financials the District system managed a 0.37x debt service ratio.

It is worth noting that the CDPH planning loan can be wrapped into a CDPH construction loan and that CDPH intends to offer an 80% grant for construction, also.
